Hello Fellow IVD Members,

With this intro clinic, we also will provide information for future planned Arduino Super Clinics, which we plan to have just like the up coming tree clinic in February.

ACHIEVEMENT PROGRAM **JUDGING**

Members of the division are encouraged to bring their models to be judged for merit awards as part of completing the requirements for their certificates in the Achievement Program.

Due to time constraints preceding division meetings, judging for merit awards will take place between 12 noon and the 1:00 pm start time of the division meeting. Those who wish to have items judged need to be prompt due to the limited one hour block of time allotted to judging prior to the meet.

For those who have models which are too large to be reasonably transported to a division meeting, are too numerous to be judged in the time constraints preceding division meetings or fall into some requirements of the Civil Engineering category, an appointment can be arranged for the assessment to be made at the location of the layout or project to be evaluated.

ILLINOIS VALLEY DIVISION Annual Election of Officers and Board of Directors 2019

Each year the members of the Illinois Valley Division elect officers and members of the Board of Directors. This year the positions open to election are: Assistant Superintendent, Paymaster and Trainmasters of Districts 1, 3 and 5. Each position will be elected to a two year term with term limits of four consecutive two year terms.

Members of the Division are encouraged to place their name on the ballot for the open positions. Any member of the NMRA and the Illinois Valley Division who is a member in good standing, resides within the geographical boundaries of the Division and has reached the age of eighteen prior to the date of taking office may place their name for an office. The age requirement for trainmasters may be waived at the discretion of the Board of Directors.

Assistant Superintendent: Two Year Term

Duties:

- 1. Shall assist the Superintendent in the performance of his/her duties and in the absence of, or inability of, the superintendent to act, shall assume any and all of 3. the Superintendent's responsibilities and duties.
- 2. Shall be responsible for the Division contests, including selection of categories of competition, interpretation of rules, criteria for judging, selection and training of judges and distribution of awards.
 - a. May appoint as many persons as necessary to assist in the handling and judging of contests.
 - b. May not enter any judged Division contest as a participant during his/her term of office.
 - c. Where practical, will attempt to make division contests conform to Regional and National norms. All contests involving model construction will be in conformity with Achievement Program judging guidelines.
- 3. Shall be the chairman of the Nominating Committee.

Paymaster: Two Year Term

Duties:

- 1. Shall be responsible for the direction and coordination of the financial activities of the Division.
- 2. Shall set up and manage all necessary bank accounts for the Division.

 Board of Directors shall contact the Assistant Superintendent stating their intent. A brief biographical state-
- 3. In the absence of, or inability of the Paymaster to act, his/her duties revert to the Superintendent.
- 4. Shall pay by check and mark "Paid" all properly ap-

- proved bills and expenses transmitted to him/her.
- 5. Shall keep an accurate record of all cash receipts, payments and disbursements, segregating them according to their respective funds or accounts.
- 6. Shall submit to all regular Board of Directors and Division business meetings a report of all income and expenses since the previous report. A written copy of this report will be given to the Chief Clerk at each meeting, to be included as part of the minutes.

Trainmasters: Two Year Terms

- **District 1:** Representing Peoria and Tazewell Counties.
- **District 3:** Representing Bureau, LaSalle, Marshall, Putnam and Stark Counties
- **District 5**: Representing Adams, Brown, Cass, Hancock, Logan, Mason, McDonough, Menard, Morgan, Pike, Sangamon, Schyler and Scott Counties.

Duties:

- 1. Shall each be elected to represent the members of the respective areas of the Division on the Board of Directors.
- 2. The geographical areas of each Trainmaster's area is listed above with boundaries to be reviewed every two years with the goal of equal membership from each district . . .
- 3. No More than one Trainmaster shall be elected from each district
- 4. If for any reason no one wishes to run for Trainmaster for a given district, the Superintendent shall appoint a Trainmaster from that district. If no one accepts the appointment, then the Superintendent shall appoint a Trainmaster at Large to represent the district with approval of the Board of Directors.
- 5. The District Trainmasters shall be responsible to coordinate the place of the meeting, clinics, and layouts on tour for the annual meeting in their district.
 - a. The trainmaster may appoint a member(s) to assist in the planning for the meet
 - b. The trainmaster may request the assistance of the Superintendent or other officers for resources available to complete the plans for the meet.
 - c. The trainmaster shall report to the Superintenddent the plans for the meet.

FOR THOSE WHO WISH OR ARE WILLING TO SERVE

HAVE YOU THOUGHT ABOUT THE ACHIEVEMENT PROGRAM

One of the incentives to join the NMRA is the Achievement Program. The program has been around since the early 1960s. Since it's inception, 625 members have attained the Master Model railroader certificate. Less than ten members attain the award each year. Not everyone is interested in the program.

You must complete requirements in seven of the eleven categories to reach the MMR status. Most are in the ability of each of us. Over the last fifty five years, only 21 members of the IVD have received one or more certificates. We have four members who have become Master Model Railroaders and four who have more than one certificate.

The hardest one to obtain is Association Official. This certificate requires the member to be a division superintendent or a region board of directors member. The easiest to get is that of Volunteer. You donate your time and effort to the NMRA region or division in its various endeavors such as giving clinics, holding an office or working an NMRA booth at a swap meet.

The areas of modeling are not that hard to achieve You must receive 87 1/2 points on a project, 70% of a possible 125 points. Yes, the quality of today's work is much greater than in the early 60s. They literally had to scratchbuild everything. I remember crude castings they made to adorn a locomotive they were building. Today we have well made detail parts.

In my years of travel and visiting many model railroads, I have seen some of those built by early MMRs and

they were crude by today's standards. My thoughts were that this is something I could do and there my quest began. The goal of the AP is to improve our skills.

In March at Peoria, we helped to judge a gondola car of Larry Nelson, a fantastic model. However, there were things that stood out as being wrong. Larry made corrections from our evaluation, then entered it at the Midwest Region Convention in Madison. He received "Best of Show" for the car.

As my travels take me around the division to various layouts, there is much talent seen. As you build your model empire, many of the requirements are being met without you knowing it. That is the easy part. Writing up what you have done and showing your research of the project is the hard part. Only you know what you have done and the time put into the project. A judging committee can only speculate (guess) from experience the extent of your endeavors without good documentation.

Why not take a look around your railroad and check the requirements for electrical engineering or scenery. Much of this has been done, such as, two trains running at the same time, having installed a switch machine, or having a place to store three locomotives on the layout. How about a crossover or a stub siding. You get the idea. You have done these things.

I achieved my MMR in 2006. I started in 1968 with the idea of being #100. Missed it by couple of hundred being #360. I procrastinated too much. Over the years I did improve my skills and was able to pass on knowledge to many others who were learning. It is time for some of you to expose your talents. The rewards are great, but as I have found my arms are not long enough to pat myself on the back.

The rewards are yours alone.

AS I SEE IT

With the March issue of the Timetable, you will receive a ballot for the election of the Assistant Superintendent, Paymaster and three District Trainmasters. Also there will be proposals which require the approval of the membership. One proposal is for changing the meeting day from a Sunday to a Saturday in the designated meeting months. The other proposal for vote is establishing a central meeting place for division meetings, presently Peoria, instead of a meeting in each of the districts each year. All members of the Illinois Valley Division are encouraged to vote.

As I see it, a central meeting place is not a good solution. Our division is the second largest in the Midwest Region. When the division was founded in 1964, our goal was to bring activity to as many members as possible. When one of our members moved to Jacksonville, we expanded to the south, When he moved to Whitehall, we expanded a second time, all the way down to Calhoun County.

In the early 1990s, the Illinois Valley Division was split up into three divisions; the Capital Division, the Rock Island Division and the Illinois Valley Division. Upon my last term as superintendent of the IVD, I had a chat with Walt Gebehart from Springfield at K-10 in Maryville while on a layout tour. Since the Capital Division was not active, did he think there was interest in rejoining the Illinois Valley Division. The same proposal was brought up in the Quad Cities and the result was the same. Thus in the early 2000s, we were unified again as a large division.

My goal was to form 5 areas or districts in order to bring activity back to each. We knew from the past that not everyone would attend all meets. Each meet would try to have two clinics and a layout tour. Layout visitations were always a big draw. We like to see what someone else has done and glean new ideas.

Meet travel has always been an issue. From Spring Valley to Quincy is about 200 miles, or a three and a half hour drive, one way. Not everyone will drive that far. I have driven it several times using different routes. It is still a long drive. Twice in the past ten years or so, we set up the trip on a real train. We had bout 15 each time. Through the efforts of Jeremy Bubb and Mike Yurgec, transportation was provided for the group to the meet and layout tour.

We have had a core group of 20 to 25 members attend our meets throughout the division. About 25% of

our membership is beyond seventy years of age and some do not attend our meets. No surprise. The younger members have other things such as family obligations and they do not attend.

If you are an average member, you have a job working Monday through Friday. Saturday is your "Honey Do Day." Sunday is church for some and "R & R" for the rest of the day to do what you want. A number of members work on Saturday or have their church obligations on Saturday. Who will the Illinois Division cater to?

Remember, your vote is important in this issue. You will be voting to have a central meeting center in Peoria or for having a meet somewhere in your district once a year.

No, you may not attend them all, but you will have the opportunity to hear clinics and see layout in your area. Each time you attend, you get to see what others in your area are doing. Remember to return your ballot by mail, e-mail or bring it to the annual meeting in Peoria on March 16, 2019.

This vote is for the good of the group, the Illinois Valley Division, as a whole.

LETS MAKE SOME LUMBER PILES

Have you got a lumber yard on your layout? Does this lumber yard have any lumber for sale? If there is a shortage of lumber, you can easily remedy this problem

and turn your lumber yard into real eye catcher. This is a one or two evening project depending on how much wood you need. The cost of materials is minimal and you may already have them om hand.



I prefer to use basswood, You could use balsa, pine, spruce or some other wood, but I do not recommend that. Basswood is available at most hobby shops and in various sizes. I model in HO scale, but theses methods will work in other scales. Basswood comes in individual board sizes for the different scales, and this could be used by simply cutting boards to length and stacking the pieces up into bunks of different sizes. This would look very good and would also be very expensive. OK! So if you are very rich, don't read any farther! The rest of this article is aimed at the very cheap people like me.

For this project I am using Midwest Products basswood 1/32"x3"x 24" grooved 1/16" flooring sheets. These sheets come in several different styles



and thicknesses. The price varies depending on your choices. Most are in the \$2.00 to \$3.00 range. One sheet will make many piles of lumber for your lumber yard.

I started by cutting a couple of scale eight foot lengths off the end of the 3"x24" sheet. I then cut those pieces into scale 4 foot wide pieces. These will be stacked one on top of another to form a bunk of lumber. Lumber is stacked in bunks to make handling easier and to aid drying. Every few layers are separated by pieces of wood called cribbage (usually scrap 2x4s). This keeps the pile stable and allows fork trucks to easily get under the bunk to pick it up.

I then take that pile and clamp it together so that I can use a jeweler's saw to slightly cut the ends at the flooring grooves to make it look like individual boards when viewed from the end. After cutting each end I unclamp the pile so that I can start making the bunk. The bunks are stacked slightly different depending on the era that you model. Older era bunks are hand stacked and thus more irregular than modern machine stacked bunks.



My era is older so I want a slightly irregular bunk. DO-NOT OVER DO THIS! One inch side to side and no more than two inches length-wise will make great shade and shadow lines Glue about five layers together, weight those piles down until dry. Then put pieces of cribbage between it and the next layer of five. Make sure that you don't forget to put cribbage under the entire pile so that it doesn't sit on the ground, so that the fork truck can get under it to pick it up.

To add visual interest, I like to add cribbage to the top of the pile and then put a few more loose boards on top to give the look of a pile that has been partially used. Make some stacks different heights from the neighboring stacks to add visual interest. The wood is left natural color like new wood and the cribbage pieces can be weathered to show being used many times, even many years. The first pile is 2"x4"x8' long pieces of wood. Make additional piles 10, 12, 16 feet long. Then make piles of 2"x6", 2"x8", 2"x10" and 2"x12" wide in all of the lengths. When you have finished this, your lumber yard will have plenty of boards to sell.

When making more modern, machine stacked bunks, you can use solid basswood strip wood 1/2"x1/4". Cut these pieces the proper lengths. Using a sharp knife blade, tap lines into the end grain to indicate the end of the individual boards in the pile Be careful here or you

will split the wood into a pile of kindling. Individual scale lumber can be added to the top of the bunk to make it look more realistic. As with the other piles, add cribbage and loose boards on top to give more visual interest.



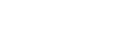


