



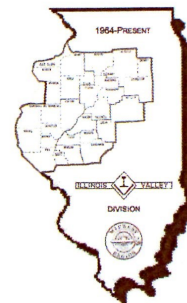

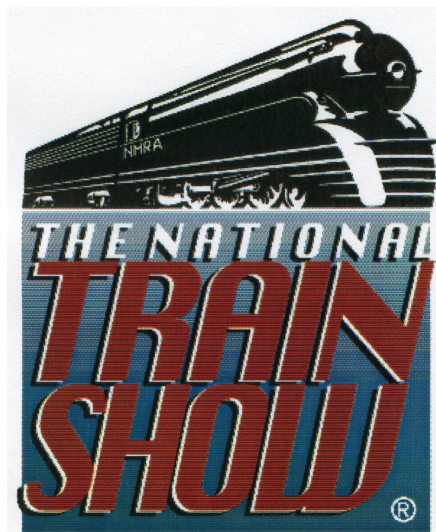

# Model Railroad Planning

Here I go again. 24 years after I started building the Culpepper & Western HO railroad, all the buildings and landscaping on two major portions of the layout are removed from their long time positions and are sitting clustered next to each other on three card tables and a couch in the next room all because I failed to plan for background scenery in the design phase. I did incorporate plaster mountains and hills in some sections that worked out pretty well and the one backdrop that I did paint behind the town of Madison was good enough to get me over the 87-1/2 point threshold necessary to earn the scenery AP but that backdrop sits behind 5 feet of town buildings and plaster hills which already gave the observer a sense of depth. The main problem I created by lack of initial planning was three long expanses of wall with track just a few inches away from the backdrop leaving little or no room for much of anything three dimensional to ease the transition to the flat wall. After watching numerous videos about how “anyone” can learn how to paint “realistic-enough” model railroad backdrops and trying my hand at various techniques, it was painfully obvious that art is not in the DNA of an engineer so my next attempt was to contact the local art guild to get a list of artists who might be willing to take on the job of painting realistic scenery on a model railroad layout and make some extra money in the process. Of the dozen or so names that the art guild gave me I got responses from only two and understandably neither was willing to spend the time it would take in my basement to paint 80 feet of walls, so I finally conceded that if I was going to have anything passable as an adequate background to improve realism on the long straight stretches of my railroad it would have to be photographic backdrops.

There are several websites that sell backdrops for model railroads. All were similar in cost so after poring over them for weeks and months I finally settled on one and made the initial contact. The owner was a model railroader himself with three different layouts in cramped spaces so he understood the problems I was facing. He also had a lot of experience at modifying photos to blend two scenes together for a smooth transition from one scene to another which would be of extreme importance in my situation. He did custom backdrops from photos taken by modelers as well, but I found his selection of backdrops along with his experience in scene transitions would be everything I would need as I gradually work my way around the 80 feet of walls in order to spread out the cost of the project. But the most impressive thing about him was the

vaunted fellowship we modelers talk about which was on full display as he took the time to talk at length about what I wanted, the perspective from which observers would be viewing each scene, and his thoughts based on his experience both as a backdrop designer and as a model railroader.

After taking a few pictures, numerous back and forth emails, and several phone conversations discussing ideas, I decided on three backdrops to start with. The first two were simple ones six and eight feet long with just trees and clouds to be installed on opposite sides of a 4 x 8 foot removable partition so I could familiarize myself with the installation process before I attempted the much harder installation of a 20 foot long continuous backdrop behind the industrial section. But before any of the backdrops could be installed I faced another conundrum. One thing I did right in the planning stage was to install a 4 foot high masonite wallboard all around the layout room and painted it sky blue from top to bottom so it was a nice flat surface to work with. Only a few of the backdrop websites advertised backdrops that high, and while it certainly would have been very impressive and would have immersed the observer totally in the scene, they were much more expensive and the thought of installing such a large backdrop was problematic to say the least on a railroad that was already up and running, so I settled for a 24” high backdrop all around the room.

To keep the viewer’s eyes from wandering above the two foot high backdrop to the blank blue wallboard above it, I decided to repaint the entire 80 feet of walls a tan color for contrast and then add a piece of trim covering the top edge of the backdrop to serve as a picture frame of sorts that would further help to keep the eyes focused on the trains. At the time of this writing my first backdrops have arrived and the wallboard repainting is completed. By the time this appears in the newsletter the first backdrops will be in place and I will be planning the next backdrop sections as I work my way around the room transitioning scenes from industrial to rural, then to agricultural, and finally to a mountain scene as I finish up, blending it in as much as possible with the existing Madison background I originally painted. With the help of my newfound model railroading acquaintance in the backdrop design business and with the help from my fellow modelers here at home to do the installation I hope to have some pictures to share in future Timetables and to put together a clinic for presentation at a future meet.

In closing, I have a few suggestions based on what I have learned about backdrops in this process:

- 1) If you are in the beginning stages of building a layout of any size, take the time to think about what you want the final scene to look like and how three

dimensional scenery that you add along the wall can be merged into a painted or purchased backdrop that makes the scene look much deeper than it really is. In addition to being much more satisfying in the finished layout, it is much easier to paint or install a backdrop FIRST. Plus, if the backdrop is already in place, it makes it easier to locate and merge trackage, hills, roads, and bridges so they realistically look like they go off into the distance.

- 2) Don't get hung up on the different types of backdrop materials, pixel densities, etc that the different suppliers promote to make their backdrops look more "realistic" than the others. I don't mean to disparage any supplier or suggest that you avoid considering the higher resolution backdrops because they are in fact awe-inspiring and draw you in with their excellent quality, fine detail, and multiple colors. So if that's your thing, go for it. But for my money, I want the viewers to focus on the trains, not the backdrop. And besides, when you go outside and look off to the horizon things aren't crystal clear or in high definition out in the distance.
- 3) Know your limitations. I decided to do this now while I'm still physically able to do it. But climbing ladders and leaning over things to repaint entire walls and installing a backdrop in sometimes inaccessible places of an existing layout can be mentally and physically challenging, so don't try to tackle it by yourself. Enlist the help of other model railroaders. I'm sure they will be glad to oblige.
